

Sibin OK

Alkaline CIP / circulation cleaner

Properties

Application

Sibin OK is a liquid cleaning concentrate for commercial use in the food industry and commercial kitchens. Sibin OK is particularly suitable for cleaning plastic crates and other wash ware in automatic conveyor systems in the meat, fish and delicatessen industries. Excellent cleaning results are achieved even with high water hardness. Dishes made of alkali-resistant plastic, stainless steel, glass and porcelain are cleaned gently and without leaving any residue. Sibin OK is also suitable for use with aluminum at the application concentration! Sibin OK does not contribute to AOX contamination of industrial waste water.

After cleaning with Sibin OK, rinse with water of drinking water quality.

Dosing

Crate washing and CIP/recirculation process

Concentration	0,3 - 1,0 %
Temperature	Mehl/Stärke: max. 40°C Eiweiß: max. 55°C sonstige Verschmutzungen (bspw. Öle und Fette): max. 80°C
Exposure time	bis 60 min.
Addition	After cleaning with Sibin OK, rinse with drinking water quality.

Dishwashers

Concentration	1 bis 4 g / l water
Temperature	gemäß Maschinentakt
Exposure time	gemäß Maschinentakt
Addition	Dosing is determined by the water hardness and the degree of soiling in the machine.

Titration

Prepare 10 ml application solution and titrate with 0.1 N hydrochloric acid against the indicator phenolphthalein.

Consumption (ml) x 0.34 = concentration in %

Store the product only in the original container and in a frost-free place between +5 and +40°C. Avoid direct sunlight. Please reseal the container tightly after removing partial quantities.
